

SNRAOID Membership Application Form

Introduction

The Info-communications Media Development Authority of Singapore (IMDA) has appointed GS1 Singapore Limited (Reg. No. 200720720G) on 8 March 2001, the then Singapore Article Number Council (SANC) as Singapore National Registration Authority for OID (SNRAOID) to implement and administer a system for the issuance of object identifiers (OIDs) in Singapore.

The terms and conditions governing the membership of SNRAOID are stipulated below.

Terms & Conditions

Application for SNRAOID Membership

Every application for SNRAOID membership shall be made on the application form prescribed by SNRAOID and submitted to SNRAOID for approval together with cash or cheque payment of the entrance fee and subscription fee for the first 12-months period. Both the first year entrance fee and the full year subscription fee paid upon joining are non-refundable and non-transferable.

Cheque payment shall be made crossed and made payable to "GS1 Singapore Limited" who acts as the secretariat for SNRAOID.

SNRAOID Membership Fee

The entrance fee for SNRAOID membership shall be S\$802.50 (S\$750.00 + 7% GST) which is only paid once at the point of registering for SNRAOID membership.

The annual subscription fee is \$\$802.50 (\$\$750.00 + 7% GST).

Arrears of Subscription

Every member of SNRAOID shall promptly pay its subscription and any other monies due and payable to SNRAOID on the due dates.

If a member falls into arrears with his subscriptions or any other monies due and owing to SNRAOID, notice shall be sent calling its attention thereto. If such member fails to make full payment after three (3) months from the date of the notice, SNRAOID shall be entitled to suspend all rights, privileges and benefits of such member until he has paid all its arrears in full.

If such member continues to default with payments for more than six (6) months or such other longer period as SNRAOID may from time to time specify, after the date of the notice, the membership of the member shall automatically terminate, provided always that the member shall be liable to pay all subscriptions and other monies due to SNRAOID up to

the date of termination of his membership and the termination of a member's membership shall not affect SNRAOID's right to recover such sum from the member.

Cessation of SNRAOID Membership

Membership of SNRAOID shall cease if the member:

- ✓ serves three (3) months' written notice of resignation to SNRAOID.
- ✓ fails to pay any fee or other sums due to SNRAOID for more than six (6) months or such longer period as SNRAOID shall determine, from the receipt of written notice from SNRAOID specifying the amount owing by the member.
- ✓ goes into liquidation either compulsorily or voluntarily or if a receiver or judicial manager is appointed in respect of the whole or any part of its assets or if the member makes an assignment for the benefit of or composition with its creditors generally or threatens to do any of these things.
